1.0 APPLICATIONS FOR THE OCTOBER 2021 EXAMINATIONS

The Board is inviting interested candidates to apply for the Professional Examinations in Architecture, Technology in Architecture, Interior Design, Landscape Architecture, Quantity Surveying, Building Survey and Construction Management that will be held in **October 2021**.

1.1 ENTRY QUALIFICATIONS:

A. ARCHITECTURE:

i) Intermediate Level:

A Candidate must hold an Advanced Diploma in Architecture or equivalent qualifications from a recognized institution.

ii) Final Level:

The Candidate must hold a Degree in Architecture or equivalent qualifications from a recognized institution or that who passed the Intermediate Examination of the Board in Architecture.

B. TECHNOLOGY IN ARCHITECTURE:

The Candidate must hold a Degree in Technology in Architecture or equivalent qualification from a recognized institution.

C. INTERIOR DESIGN:

The Candidate must hold a Degree in Interior Design or equivalent qualifications from a recognized institution.

D. LANDSCAPE ARCHITECTURE:

The Candidate must hold a Degree in Landscape Architecture or equivalent qualifications from a recognized institution

E. QUANTITY SURVEYING:

i) Intermediate Level:

The Candidate must hold an Advanced Diploma in Building Economics / Quantity Surveying or equivalent qualifications from a recognized institution.

ii) Final Level:

The Candidate must hold a Degree in Building Economics/Quantity Surveying, or equivalent qualifications from a recognized institution or that who passed the Intermediate Examination of the Board in Quantity Surveying.

F. BUILDING SURVEY:

The Candidate must hold a Degree in Building Survey or equivalent qualifications from a recognized institution

G. CONSTRUCTION MANAGEMENT:

The Candidate must hold a Degree in Construction Management or Equivalent qualifications from a recognized institution.

H. REFERRALS:

Candidates who attempted the Examinations of the Board in the previous year and were referred in certain subject(s) are highly encouraged to re-sit the same in October 2021 examination session.

The deadline for submission of applications for the examinations is on 11th June 2021 at 4.00 pm.

2.0 SUBMISSION OF EXPERIENCE REPORTS:

The deadline for submission of the Experience Reports for Final Level Examinations is on **16th July, 2021** before **4.00 pm** and for re sitters on **20th August 2021** (**Ensure Use of New Standard Logbooks available in the website (www.aqrb.go.tz) checked and signed by the Board quarterly ;Nevertheless the duration of Professional Practical Training should be not less than two years after graduation**) Submission of the experience Reports (Three copies one original and two copies) must be accompanied with a non- refundable fee of Tzs.70,000/= paid through Bank Payment control number issued at AQRB Office.The Diary sheets must be duly filled in by HAND, signed by the Candidate and the Supervisor, and must be stamped by the Supervisor.

3.0 MODE OF APPLICATION:

Letters of applications for the Examinations must be accompanied by duly filled prescribed form obtainable from the Board's website (www.aqrb.go.tz) addressed to the undersigned. The cost of the form is **Tzs. 20,000/=**. Additionally for the final candidates, they must be accompanied with a letter from the Supervisor stating that the applicant has acquired sufficient professional practical experience and is ready for the Board's examinations.
