INVITATION FOR APPLICATION FOR THE NOVEMBER 2020 FINAL EXAMINATION FOR SENIOR LOCAL GRADUATES IN ARCHITECTURE, QUANTITY SURVEYING AND ALLIED DISCIPLINES

Architects and Quantity Surveyors Registration Board is a Government Institution established to enforce the Act No.4 of 2010; among its function is to register and regulate conducts of Architects, Interior design ,Landscape Architects, Quantity surveyors, Building surveyors, construction managers, Project Managers and their firms.

Pursuant to clause 63(2) of the GN. No.377 of 2015, the Board in its endeavour to enhance registration process has decided to fast track registration of senior graduates in architecture, quantity surveying and allied discipline and is inviting all eligible senior graduates in architecture, quantity surveying and allied disciplines to apply for registration. The following are criteria for application to candidates:

1. Holder of an advanced diploma or equivalent qualifications in the respective disciplines from recognized institutions;
2. Graduated in the relevant field in year 1998 or before;
3. To have obtained professional practical experience in the relevant field for not less than ten (10) years.

Take Note:

- i. All graduates, who meet the above criteria, are required to submit their applications letters to the undersigned, including current signed curriculum vitae and certified academic and professional certificates and transcripts to the undersigned by **July 30, 2020**;The application fee is **Tsh. 20,000/=**
- ii. There will be no written examinations;
- iii. The November 2020 examination session is the last opportunity for senior applicants;
- iv. Those qualified for registration process will be informed by the Board to submit duly filled logbook, in the respective discipline, obtained in the Board website (www.aqrb.go.tz). The **deadline for submission of the Logbooks** for Final Level Examinations is **on 14th August, 2020 at 4.00 PM (Ensure Use of New Standard Logbooks)**. Submission of the experience Reports (Three copies one original and two copies) must be accompanied with a non-refundable fee of **Tzs.70, 000/=** paid through **Control number** issued from our offices in Dar es Salam and zone offices in Dodoma, Arusha, Mwanza and Mbeya.

The Diary sheets must be duly filled in by HAND, signed by the Candidate and the Supervisor, also to be stamped by the Supervisor when necessary.
