# INVITATION FOR APPLICATIONS OF THE OCTOBER 2024 BOARD'S EXAMINATIONS

The Board is inviting Eligible Candidates to apply for the Professional Examinations in Architecture, Technology in Architecture, Interior Design, Landscape Architecture, Quantity Surveying, Building Survey and Construction Management that will be held in **October**, **2024**.

### **1.0 ENTRY QUALIFICATIONS:**

### A. ARCHITECTURE.

### i) Intermediate Level:

A Candidate must hold an Advanced Diploma in Architecture or a degree with less than 5 years training in Architecture from recognized institution.

#### ii) Final Level:

The Candidate must hold a first Degree in Architecture, Technology in Architecture, Interior Design, Landscape Architecture or equivalent qualifications from a recognized Institution or that who passed the Intermediate Examination of the Board in Architecture.

#### **B. QUANTITY SURVEYING**

#### i) Intermediate Level:

A Candidate must hold an Advanced Diploma in Building Economics / Quantity Surveying or a degree with less than 4 years of College training in Quantity Surveying/ Building Economics from recognized institution.

#### ii) Final Level:

The Candidate must hold a first Degree in Building Economics/Quantity Surveying, Building Survey and Construction Managementor equivalent qualifications from a recognized Institution or that who passed the Intermediate Examination of the Board in Quantity Surveying.

#### 2.0: REFERRALS:

Candidates who attempted Examinations of the Board in the previous year(s) and were referred in certain subject(s) are highly encouraged to re-sit the same in **October**, **2024 examination session**.

#### **3.0: MODE OF APPLICATION:**

Application letter to sit for Board's Examinations must be accompanied with duly filled prescribed form obtainable from online registration system (ors.aqrb.go.tz) at a cost of Tzs. 20,000/=. For the final candidates, their applications must be accompanied with a recommendation letter from the Supervisor stating that the applicant has acquired sufficient professional practical experience and is ready for the Board's examinations. All applications are to be submitted in HARDCOPY in any of AQRB offices located in Dodoma, Dar Es Salaam, Mwanza, Mbeya and Arusha.

The deadline for submission of applications for the examinations is <u>on 15<sup>th</sup> July, 2024</u> <u>before 4.00 pm.</u>

#### 4.0: SUBMISSION OF EXPERIENCE REPORTS (LOGOBOOKS):

Candidates for Final Level Examinations are **reminded to use instructions/ checklists provided in the logbooks** when filling their logbooks. Further; Candidates are **obliged** to submit their logbooks to the Board for Verification <u>atleast 15 days before date of final submission on</u> <u>15<sup>th</sup> August, 2024 before 4.00 pm</u> (Ensure Use of New Standard Logbooks available in the online registration system (ors.aqrb.go.tz) checked and signed by the Board quarterly; Nevertheless the duration of Professional Practical Training should be not less than two years after graduation).

Submission of the Logbooks (Three copies, one original and two photocopies) must be accompanied with a non- refundable fee of Tzs.70,000/= paid through Control number issued by AQRB. The Diary sheets in the logbook <u>must be duly filled in by HAND, signed by the</u> Candidate and the Supervisor and be stamped by the Supervisor as the case may be.
