Note:

- Candidates with **PASS** are required to apply for professional registration through the Board's Online Registration System (ors.aqrb.go.tz) and pay prescribed registration fee amounting **Tsh. 310,000/=** by **31st December, 2025**, to enable the Board to effect their registration. They are also required to upload their updated **AAT** or **TIQS** active membership status. The control number will be generated online upon submission of applications.
- Candidates with **'FAIL'** have been referred to both subjects while those with **'REF'** remarks have been referred to the specific subject. Candidates in both cases are highly encouraged to re-sit the said examination during the next examinations session in **May 2026**.
