- Candidates with **PASS** are required to apply for professional registration through the Board's Online Registration System (ors.aqr.go.tz) and pay prescribed registration fee amounting **Tsh. 310,000/=** by **30th March, 2025**, to enable the Board effect their registration. They are also required to upload their updated **AAT or TIQS** active membership status. The control number will be generated online upon submission of applications.
- Candidates with **'FAIL** have been referred to both subjects while' those with **'REF'** remarks have been referred to the specific subject. All candidates are highly encouraged to re-sit the said examination during the next examinations session in **May 2025**.
